## REQUIREMENTS

### PLEASE READ REQUIREMENTS CAREFULLY

1. To be eligible for a scholarship the applicant **must** either be a member of a local union affiliated with the Bergen County Central Trades and Labor Council AFL-CIO or his/her spouse and/or children.
2. Each application **must** be accompanied with a transcript from the most recent institution of learning.
3. Each application **must** be accompanied with a short essay on your connection to the labor movement.
4. The scholarship shall be applicable solely for accredited college and accredited nursing school programs.
5. The recipients of the scholarships must be enrolled at an accredited college or accredited nursing school.
6. The scholarship will be granted to students for a period of one academic year.
7. The scholarship will be available to full and part-time students.
8. The Scholarship Committee shall recommend recipients for the award based on merit, which will be determined by scholastic ability or its equivalent. Consideration of financial need will enter only under extraordinary circumstances.
9. RETURN BY **FRIDAY, April 30, 2010.**

For the above fiscal year, the amount of each scholarship shall be \$1,000.00. A total of one scholarship will be awarded. **Only recipients will be notified.**
